

DISTRICT OF CHETWYND

BYLAW NO. 935, 2011

Being a Bylaw to Establish a Municipal Ticket Information System within the District of Chetwynd

WHEREAS pursuant to the *Community Charter* Council may authorize a Council to establish, by bylaw, a means to designate those Municipal Bylaws which may be enforced by way of a Municipal Ticketing System; the offences which are subject to municipal ticketing; who is empowered to issue municipal tickets; and what fines may be imposed for each offence.

NOW THEREFORE the Council of the District of Chetwynd, in open meeting lawfully assembled, hereby enacts as follows:

1. CITATION

This bylaw may be cited as the “District of Chetwynd Municipal Ticket Information Bylaw No. 935, 2011”.

2. APPLICATION

This bylaw shall apply to the geographic area of the District of Chetwynd.

3. GENERAL PROVISIONS

- 3.1. Those bylaws, as amended or replaced from time to time, listed in Column 1 of Schedule “A” attached to and forming part of this Bylaw may be enforced by means of a ticket in the form prescribed for the purposes of section 264 of the *Community Charter*.
- 3.2. In Schedule “A” attached to and forming part of this Bylaw, those persons appointed to the job positions or titles listed in Column 2 are hereby designated as Bylaw Enforcement Officers under section 264 of the *Community Charter*.
- 3.3. The words or expressions set forth in Column 1 of Appendices 1 through 8 to this Bylaw designate the offence committed under the bylaw section number appearing in Column 2 opposite the respective words or expressions.
- 3.4. The amounts appearing in Column 3 of Appendices 1 through 8 to this Bylaw are the fines set under Section 265 of the *Community Charter* for the corresponding offences designated in Column 1.

4. SEVERABILITY

If any portion of this bylaw is for any reason held to be invalid by a Court of competent jurisdiction, the invalid portion shall be severed without affecting the remainder of the bylaw.

5. EFFECTIVE DATE

This bylaw shall come into full force and effect upon its adoption.
