Sunset Prairie Lodge presently is housing 271 workers. No personal vehicles allowed on site. This could have implications for workers from Chetwynd as the busses travel only from Fort St. John and Dawson Creek.

I asked how many workers with Chetwynd addresses are in camp. No answer."
