D-1 Sgt. Scott Hromadnik, Chetwynd **RCMP** 7580.20

Sgt. Hromadnik, Chetwynd RCMP presented Council with a brief presentation on the third quarterly policing report (October 1 – December 31, 2016) in Chetwynd as outlined below:

- Auto theft, property crime and violent crimes were all down compared to 2015
- Traffic offences went up 145%, meaning more offenders were caught
- 17 impaired driving charges
- Two Chetwynd Constables will be recognized by the North District for Alexa's Team for their commitment to reducing impaired driving
- The Drug Abuse Resistance Education (D.A.R.E.) program is still ongoing in the elementary schools
- Chetwynd will be losing Cst. LeMay, Rose and Taylor as of Spring 2017 due to transfers; Corp. Scott Clay has also been transferred
- The North District has received a helicopter for this area, to be based in Prince George
- Cops for Cancer is up and running again and will be coming through Chetwynd in September 2017

D-2 Louise Knox, Victim Services 7500.20.06

Louise Knox, Victim Services Coordinator presented Council with a brief presentation with regard to Victim Services activities in 2016 as outlined below:

- Provides a number of services including: helping women who require the use of a safe house to escape from domestic abuse, safety planning, next of kin notification, court appearances, support services for court. counselling referrals, etc.
- Had 107 clients in 2016; Hudson's Hope is also included in service area

• Involved in Violence Against Women in Relationships (VAWIR), Mental Health Initiative, and Community Services

WHEREAS the ongoing shortages of manpower in Ambulance Halls throughout rural British Columbia are prevalent in most communities outside of larger Urban Centres;

AND WHEREAS because of the declining volunteer nature of the B.C. Health Emergency Service (BCHES)'s ambulance service it is critical that the BCHES be properly addressed by the Province to ensure life safety while respecting budgets:

NOW THEREFORE be it resolved that the North Central Local Government Association adopt the following resolution and forward it to the Union of British Columbia Municipalities for ratification and submission to the Province of British Columbia:

"THAT the Provincial Government be requested to initiate a full and indepth review of B.C. Health Emergency Service (BCHES)'s ambulance service in British Columbia, with the intent of modernizing those services to consider additional duties to warrant more full time value and work for ambulance personnel, and that such review be made a high priority of the government of British Columbia."; and

WHEREAS employer-paid health and dental plans are currently a non-taxable benefit to employees;

AND WHEREAS the Federal Government is considering taxing these employer-paid health and dental contributions, which would have significant consequences including increasing the federal and provincial income tax payable by employees, possible increases to CPP and EI contributions, payroll administration changes, and resulting in decreased take-home pay for employees:

NOW THEREFORE be it resolved that the North Central Local Government Association endorse that the Government of Canada be petitioned not to tax employer-paid health and dental plan contributions because of the significant negative impact this will have on the people who form the work force in Canada, and employers who would have to administer the payroll changes, and that this resolution be forwarded to the Union of British Columbia Municipalities for ratification and submission to the Government of Canada.
