WHEREAS Division 12 of Part 3 of the *Community Charter* (the "Charter") authorizes Council to impose a remedial action requirement of the owner or owners of a building including a requirement to remove or demolish the building where: 1) Council considers that the building is in or creates an unsafe condition; 2) Council considers that the building contravenes the Provincial building regulations or a District of Chetwynd bylaw under Section 8(3)(1) [(buildings and other structures)]; and 3) Council declares the building is a nuisance;

AND WHEREAS Maria Correa is the registered owner (the "Owner") of a building (the "Building") known as 5216 47 Avenue, Chetwynd BC,

NOW THEREFORE, the Council of the District of Chetwynd, in open meeting assembled, resolves as follows:

- 1. THAT Council, having received a report from the Fire Chief dated December 6, 2013 hereby considers that the Building located at 5216 47 Avenue, Chetwynd BC is in and creates an unsafe condition within the meaning of 73(2)(a) of the Charter, as a result of the Building being left vacant and not being maintained, and continuing to deteriorate.
- 2. THAT Council hereby declares that the Building is a nuisance, within the meaning of Section 74 (2) of the Charter, as Council considers the building to be so dilapidated and unclean so as to be offensive to the community.
- 3. THAT Council hereby requires pursuant to its remedial action powers under Part 3, Division 12 of the Charter that the Owner demolish and remove the Building no later than forty five (45) days after notice of this remedial action requirement under Section 77 of the Charter has been sent by the District of Chetwynd to the owner;
- 4. THAT the District of Chetwynd provide notice to the Persons entitled to notice under Section 77 of the Charter;
- 5. THAT the District of Chetwynd notify the Persons entitled to Notice under Section 77 of the Charter that they may request that Council reconsider the *Remedial Action Requirement* pursuant to Section 78 of the Charter by providing the District of Chetwynd written notice within 14 days of the date on which notice under Section 77 of the Charter was sent; and

6. THAT if any or all of the actions required by the *Remedial Action Requirement* are not completed by the date set out above, the District of Chetwynd may undertake any or all of the actions required by the *Remedial Action Requirement* at the expense of the Owner, as authorized by Section 17 of the Charter.

13. Question/Answer Period

Terry Halliday:

• Inquired what the time frame would be for demolition of the abandoned house at 5216 47 Avenue.

The Chief Administrative Officer responded that tonight Council authorized Administration to begin the legal process to have the house demolished. The owner will be contacted and provided 14 days to request to appeal Council's intent at the August 10, 2015 Regular Council meeting. The owner may decide to have the house demolished before Administration is able to complete the legislative process to do so.

Chris Newton:

• Inquired whether the time frame for demolition would be the same if the house were used for fire practice?

The Mayor responded that the time frame would be the same, but that fire practice is no longer considered feasible in this situation.

Russ Young:

• Inquired at what point would a First Nation need to disclose what they intend to do on land declared Treaty Land Entitlement (TLE)?

The Chief Administrative Officer responded that the District of Chetwynd does not have control over which parcel a First Nation may select for TLE, but there is a process through which the District can negotiate services to that parcel.
