Jean-Pierre Hoyeck from TransCanada provided information re: the Proposed North Montney Pipeline Project. TransCanada has been operating for 60 years, owns \$48 billion of premium pipeline and energy assets and are located in 7 provinces and 32 states.

The proposed Project is in the Peace River Regional District, is approximately 305 kms long and will have metering facilities, valve sites and possible compression facilities. The south end will connect with the northern end of the existing Groundbirch Mainline (Saturn Section), located about 35 km southwest of Fort St. John. The north end will be about 190 km northwest of Fort St. John and will tie into a new meter station.

The North Montney Mainline is broken out into two sections; Aitken Creek Section in the south end and the Kahta Section in the north end. The Aitken

Creek section will be approximately 180 km of up to 48 inch diameter pipeline and the Kahta section will be approximately 125 km of up to 48 inch diameter pipeline connecting to the north end of the Aitken Creek section.

B.C has an abundance of natural gas resources, and new natural gas pipelines such as the proposed North Montney Mainline (Aitken Creek and Kahta sections) will provide the capacity needed to transport natural gas from northeast B.C. to demanding energy markets.

TransCanada is having a Community Open House BBQ in Chetwynd early to mid-August (possibly August 14, 2014); they will be sending an information package in 1-2 weeks.

Mr. Hoyeck responded to various questions from Council regarding this project.

Council thanked TransCanada representatives for the presentation.

> "Worker Camps. A special Committee of the Whole was held on June 27 to hear a report from Bill Beamish (W. Beamish Consulting) and Johan Stroman (Heartwood Solutions) on the extent, effects, and control of worker camps.

> Quoting from the cover letter: The results [of the study] reveal that no single agency has a full understanding of the work camp locations, size, and impacts on communities.

> And quoting from the Executive Summary: The region is poised to see a significant rise in the population of transient workers and the number of work camps if proposed projects move forward. There is a need for information sharing and collaboration across the regulatory agencies, on ongoing means to have an accurate count of transient workers in the region and their locations, and a social impact assessment and a plan for mitigating impacts in communities.

> Without proactive new structures for gathering data and working together there are potentially serious consequences for rural and urban land use planning, community social planning, as well as emergency planning and response. Without the whole picture it is also difficult to advocate, act and monitor change in the region.

> My conclusion: A coordinated approach among the plethora of agencies involved in regulating some factor of worker camp placement and operation is not likely in the near term."
