Leo Sabulsky, Fire Chief/MEP Coordinator provided Council with an update on the recent flooding event as outlined below:

- Special thank you to the Director of Engineering & Public Works and the Public Works team for working tirelessly during the flood event to prevent further damage to the community
- Many local contractors helped out and advised they felt it was their civic duty
- Areas of high risk were Windrem Creek/Post Office bridge, Spirit Park, Wabi Crescent, Surerus Place, Widmark Creek by Tirecraft, 46th Street by Canfor log yard & 46th Street toward the airport
- Yesterday was the last day of response and crews are now starting cleanup and recovery
- Disaster Financial Assistance Program is available for residents and rural residents; there will be a Town Hall meeting at 7:00 p.m. on Tuesday, June 21, 2016 at the Cottonwood Hall at the Chetwynd Rec. Centre
- A Red Cross Resiliency Centre is being set up at the Chetwynd Rec.

CR-1 Regional District Report 0400.70.02 Mayor Nichols submitted the following written Peace River Regional District (PRRD) report dated June 9, 2016:

"R-21. The following recommendations affecting the District of Chetwynd and area were approved:

- That the Regional Board authorize a Canada 150 infrastructure grant application on behalf of the Chetwynd Civic Properties Commission to be submitted for the Chetwynd Recreation Centre for repairs and upgrades to the chiller, condenser arena floor, ventilation system and curling rink brine headers.
- That the Regional Board provide permission to the Civic Properties Commission to undertake renovations to repair and upgrade the chiller, condenser, area floor, ventilation system and curling rink brine headers as included in the 2016 five year financial and capital plan.

The Canada 150 grant could provide up to \$500,000 to offset an estimate cost of from 2.22 million to 2.53 million.

B-3. Encana's proposal to re-designate and rezone 19.37 ha of the southeast ¼ of Section 31, Township 25, PRD for the construction and

operation of a battery and production facility (Dawson South Centralized Liquids Hub) was sent back for a second public hearing to be held in July."

- Northern Health is encouraging patients to go to the clinic and to only go to the ER for emergencies as Chetwynd has a high number of patients being seen in the ER for non-emergencies
- Waiting for report/strategic plan on Healthy Living for Children
- 2 nurses have just signed on with 3 year contracts; 2 registered nurse positions are currently posted
- Currently have 2 home support workers with approximately 20 clients
