Community Fitness Challenge:

- Received Imagine grant last summer
- Challenge was started to promote active healthy living and to provide information on cardiac health
- Challenge was starting to walk from Chetwynd, BC to Chetwynd, ON and was accomplished in 1 week; Chetwynd, ON is no longer there as it has now been amalgamated into the Township of Armour
- Are now walking to Chetwynd, Australia and are on Week 4; this may also have been accomplished after Week 4 inputs and if it is then will walk around the world

Library Programs:

- iRead started in Fall of 2014
- Open to Children in Grade 2-6
- Children come in twice per week for reading intervention
- Children are finding success and confidence in reading
- Library can take 12 children at a time in the program

Exterior Redesign Project:

- Completion date of 2016
- Cost analysis is underway
- Applying for a Northern Development Initiative Trust grant for \$25,000.00
- Will be consulting a professional firm to assess roof
