D-1 Jay Morrison, Enbridge Inc. re: Spruce Ridge Expansion Project 6850.50.09

Jay Morrison, Enbridge Inc. provided Council with a brief presentation as outlined below:

• On February 27, 2017, Spectra Energy completed its merger with Enbridge to become the largest North American energy infrastructure company; Spectra Energy will now be carrying on business in British Columbia as Enbridge Inc.

Jackfish Lake Expansion Project:

- Pipeline construction underway
- April 2017: Project scheduled in-service
- Summer-Fall 2017: Final clean-up and worksite restoration

High Pine Expansion Project:

- Jan April 2017: North loop clearing and construction
- July Dec 2017: South loop construction
- End of 2017: Project scheduled in-service

Wyndwood Expansion Project:

- December 2016: Received National Energy Board hearing notice
- 2017: Regulatory review occurring
- Construction could be delayed to late 2017

Spruce Ridge Expansion Project:

- Potentially adding a 24 km, 36 inch pipeline loop; the pipeline loop would largely parallel an existing pipeline right of way
- The proposed pipeline would start ~17 km southwest of Chetwynd and end ~7 km northeast of the District; ~6 km of the proposed 24 km pipeline would proceed through a greenfield route south of Chetwynd
- Adding new compressor units to N5 and CS2 compressor stations to accommodate an increased volume of natural gas
- Project planning, environmental studies and consultation has begun, and will continue as this project progresses

- The project is scheduled to have an in-service date in the first half of 2019
- An open house is planned for Chetwynd in Spring 2017

Chad Iverson, BC Paramedics provided Council with a brief presentation as outlined below:

- Circulating a petition to amend the Fire and Police Services Collective Bargaining Act
 - The draft Bill proposes to:
 - Give ambulance paramedics the same collective bargaining rights as firefighters and police officers
 - Retitle the Act to the Ambulance, Fire and Police Services Collective Bargaining Act
 - Change the definition of "employer" under the Act to include the employer of members of a paramedics' union, and define "paramedics' union" as a bargaining unit in which the majority of employees are engaged in ambulance paramedic duties
 - Remove the right of ambulance paramedics to strike and the right of their employer to lockout during an impasse in collective bargaining and would require resolution of the impasse through binding arbitration
 - Remove the paramedics' union as a bargaining unit under the Health Authorities Act
- Requested a letter of support from Council
