Sheree Smith asked if the District would review the decision made to eliminate the Bylaw Enforcement Officer (BEO) position.

The Chief Administrative Officer responded that the District still enforces bylaws under the policy of Council by complaint. This bylaw enforcement issue started while the BEO was employed but the Administration Department started the enforcement process.
