Plan 7500.20.01 Sergeant Olivia Tremblay, Chetwynd RCMP provided Council with a brief presentation regarding Chetwynd RCMP Initiatives of 2016/17 Annual Performance Plan as outlined below:

Overview of 2015/2016 Fiscal Year:

Drugs:

• Made 28 drug seizures; the main drug seized was marihuana; also participated in 3 drug awareness presentations to schools

Traffic Enforcement:

- Conducted a total of 615 contacts which included: 226 violation tickets, 313 warnings, 14 24-hour driving prohibitions by alcohol, 2
 24-hour driving prohibitions by drugs, 41 immediate roadside prohibitions (over .08mgs), 15 criminal code impaired driving investigations and 4 criminal code refusals
- Cst. Adam Taylor has been nominated to the Alexa Team BC (recognized for conducting over 12 impaired driving investigations)
- No fatal motor vehicle accidents this reporting year

Domestic Violence:

- Forwarded 33 domestic violence charges to Crown this year (29 last year)
- Police Based Victim Services Louise Knox and FNCP Cst. Harvey are active in the Violence Against Women in Relationships Committee in Chetwynd; each member has been tasked at spending more time/more awareness/more support with victims

Youth:

 Cst. Damian Moe completed DARE training at Windrem Elementary School; Cst. Marc Tremblay coached hockey; Cst. Sue Harvey initiated a Code Blue fitness program in Chetwynd, and was also assistant coach for girls' basketball; members have each been assigned a school to participate in school visits 2016 – 2017 Initiatives

Domestic Violence:

- Continue to support victims; initiate awareness/training activities Traffic Safety:
- More focus on visibility rather than statistics (tracking monthly patrol hours)

Social Chronic Offender/Prolific Offender:

• Identify problem persons and deal with them (ie criminal charges, healing/treatment, other government agencies, etc.)

Youth:

• Continue involvement with youth

Chainsaw Carving Vandalism:

• Two youth have been arrested and have been charged with mischief over \$5,000
