Project Proposal

Tim Bennett, Ministry of Forest, Lands and Natural Resource Operations provided Council with a brief presentation as outlined below:

- The Recreation Sites and Trails BC (RS&T BC) branch of the Ministry of Forests, Lands and Natural Resources would like to propose entering into a partnership with the District of Chetwynd to assist in developing a public safety advisory for Avalanche Awareness in the Northeast Northern Rockies
- RS&T BC is working with the local Pine Valley Trail Blazers Snowmobile Club to manage the outdoor recreation experience in these areas
- RS&T BC has also partnered with Avalanche Canada to produce Avalanche Terrain Exposure Scale (ATES) mapping for the areas
- Proposal is to partner with the local governments of Chetwynd, Tumbler Ridge and Mackenzie along with RS&T BC, with each contributing \$2,500.00 to a total of \$10,000.00
- Funds would be used to contract an Avalanche Professional to provide snow conditions for the Core Lodge; Wolverine; Bullmoose; Burnt River; Hasler; Silver Sands; Pine Bowl and Morfee Mount riding areas

D-2 Sgt. Olivia Tremblay, Chetwynd RCMP re: Results of 2014/2015 Policing Year and 2015/2016 Goals Sgt. Olivia Tremblay, Chetwynd RCMP provided Council with a brief presentation as outlined below:

Chetwynd RCMP 2014/15 objectives and results:

1. Reduce the Abuse of Drugs: Chetwynd detachment made 31 drug seizures, the majority of which were marihuana, but also including cocaine and prescription meds.

Chetwynd detachment made 1 Possession for the Purpose of Trafficking charge.

2. Contribute to Safe Roads: Chetwynd detachment members made 656 traffic contacts, this includes traffic tickets, warnings, roadblocks and so on.

Chetwynd detachment members conducted 6 roadblocks.

- 3. Contribute to Police community relations Youth: All members of Chetwynd detachment were involved in youth initiatives. Breakdown:
 - Cst. Marc Tremblay coached hockey
 - Cst. Ryan Lemay coached volleyball at the high school
 - Cst. Kyle Rose helped coach basketball at the high school
 - Cst. Ivan Szulhan was on the Chetwynd Youth Group board assisting with organizing their events
 - Cpl. Brian Hromadnik refereed hockey
 - Cst. Adam Taylor assisted with Air Cadets inspection/parade
 - Sgt. Olivia Tremblay is a director on the Pine Valley Exhibition Park board organizing events for youth
 - Cst. Sue Harvey, First Nations Community Police officer coordinates many activities for youth on our two first nations communities, such as camp outs, sports, cultural events and so on.
 - Members also were each assigned a school and must conduct monthly school visits.
 - Members also attended bike rallies at the day care.

In 2014/15 Chetwynd detachment responded to 2179 calls for service and lodged approximately 260 prisoners.

2015/16 Initiatives:

Drugs – Chetwynd detachment will continue to work on identifying and charging drug traffickers in the area as well as pursuing drug awareness initiatives.

Traffic – Chetwynd detachment will continue to work on traffic initiatives especially related to impaired driving offences. This will be done with routine vehicle stops, roadblocks and multi-agency traffic initiatives.

Domestic Violence – Chetwynd Detachment will attempt to drive incidences of domestic violence in our area down by increasing awareness, partnering with other agencies/resources and providing training opportunities.
