D-1 Windrem PAC re: Chetwynd's French Immersion 0400.90.11 Corrina Kennedy, Windrem PAC provided Council with a brief presentation as outlined below:

- Had difficulties finding out about the French Immersion program in Chetwynd
- École Windrem Elementary did not show up on a google search of Chetwynd schools when she initially searched for French Immersion Schools
- The School District 59 webpage made no mention of French Immersion being available at Windrem Elementary
- Thanked the District of Chetwynd for including information about French Immersion on its website
- After contacting the School District office, they changed their website to include École Windrem Elementary
- The School District needs 18-22 new registered students each year to continue offering the French Immersion program; numbers this year are short of the target

D-2 Marti Rainey re: Chetwynd Community Foundation 0230.50.30

Marti Rainey, Chetwynd Community Foundation provided Council with a brief presentation as outlined below:

- The Chetwynd Community Foundation is a registered not-for-profit group that funds programs in the community
- Have a principal fund in the amount of \$136,043 that is never touched
- Have distributed \$7,750 in grants and have a \$500 grant pending for a total of \$8,250 distributed within the community
- Need to increase membership and funding; are seeking dynamic new members who enjoy fundraising

13. Question/Answer Period

Terry Halliday inquired if the increase in fees for Water, Sewer and Solid Waste Collection in Items B-1, B-2 and B-3 are part of the Five-year Financial Plan that was approved earlier this year.

The Director of Financial Administration responded that the rate increases are in line with the rate increases that were adopted last Spring as part of the Five-year Financial Plan but that there was a slight shift in where the funds will be allocated; however the value didn't change.

Terry Halliday further inquired once the Wolverine Mine reopens if the coal trucks coming from Wolverine Mine would be able to use the Falling Creek Road to Willow Creek, which Conuma Coal currently uses to transport coal from the Brule mine, or if they would be using the highway.

The Mayor responded that he would need to talk directly to Conuma Coal for the answer.

Terry Halliday further commented that we would endure damages to the highway through town if the coal trucks hauled on it through the winter.

Council responded that it is a public highway and that we can't stop the coal trucks from using it.

Terry Halliday further inquired if the District could provide incentives to encourage families to move to Chetwynd.

Council responded that the Economic Development Officer works with industry to provide information packages for potential new employees and new businesses considering locating in this area.
