"South Peace and North Peace Search and Rescue made a presentation and a plea for the RD to consider some level or regular funding.

The proliferation of worker camps, especially in the Pink Mountain area is becoming increasingly problematic to the PRRD. Concerns include traffic pressures on the Alaska Highway and the secondary roads, policing, water and sewer and the potential for social disruption when thousands of workers live in camps. The PRRD will attempt to take its message on worker camps to the full Cabinet.

The PRRD voted to change the oath of office to recognize the federation nature of the RD.

The PRRD would like to receive submissions from each municipality for a RD submission to the 10-year transportation plan being proposed by the Ministry of Transportation.

STARS made its annual report to the PRRD Board and noted that the Valley View Hospital completed its helipad in cooperation with the community, industry, and the local First Nation at a cost of \$250 thousand."
