4. Delegations & Presentations

D-1 Jesse Rashke and Ken Wolfe, West Fraser Mills Ltd. Jesse Rashke and Ken Wolfe, West Fraser Mills Ltd. presented Council with the following presentation:

- West Fraser purchased Northern Wood Preservatives in 1978 and Chetwynd Forest Industries in 1979
- In 1980 the two mills were replaced with a larger facility at the current site
- Recent upgrades to mill and construction of Bioenergy plant
- In 2015 we completed a major rebuild of the mill, which included a new large canter line, and a rebuild of the back end of the mill
- We also completed construction of a 12 megawatt Bioenergy plant which is under a 20 year contract to produce green energy for BC Hydro. The bioenergy plant utilizes sawmill residue, and has allowed us to de-commission the beehive burner
- This year we completed the Continuous Dry Kiln
- Capital investment since 2013 exceeds \$130 million
- 250 Direct employees; hundreds of indirect employees; Logging contractors; Log haulers; Consultants; Planning, Engineering services, Environmental management; Reforestation contractors
- Mill consumption is 1,250,000 m3 of timber/year; Approximately 22,000 logging truck loads per year.
- Forest License has an Annual Allowable Cut (AAC) of 371,567m3/year in the Dawson Creek Timber Supply Area (TSA)
- Chetwynd Forest Industries currently holds no licenses in the Fort St. John Timber Supply Area (TSA)
- Approximately 875,000m3/year of unsecured volume
- Currently undergoing a TSR for the Fort St. John Timber Supply Area (TSA); Timber Supply Review process happens on a regular basis, and was last completed in 2003 in the Fort St John Timber Supply Area (TSA)
- What Role can the District of Chetwynd Play?
 - The Mayor and Council can advocate for the forest industry and its importance to the community of Chetwynd, and the region
 - o Ensure that the Minister of Forests understands that the forest resource in the Fort St. John Timber Supply Area (TSA), both green timber and dead beetle killed pine is underutilized
 - o Access to the resource is critical to the long term economic health of the local forest industry
 - o Advocate for the Minister to 'Apportion' any 'Uplift' volume (or volume made available above existing license needs) that may be made available by the Chief Forester's Determination' to new competitive license opportunities

D-2 Mayor McPherson and CAO Jordan Wall, District of Tumbler Ridge re: 2017 Strategic Plan of the Northeast BC Resource Municipalities Coalition and Request that Chetwynd Consider Rejoining the Coalition

Mayor McPherson and Jordan Wall, Chief Administrative Officer, District of Tumbler Ridge presented Council with the following presentation:

- Requested Chetwynd re-join the Northeast BC Resource Municipalities Coalition
- Explained that Chetwynd would benefit since the coalition would advocate for Chetwynd with discussions with provincial and federal governments
- A group of municipalities has a better chance of being heard, than a single municipality
- The fee for Chetwynd to re-join has been reduced from \$40,000 to \$27,700 and is calculated based on population
- Fort St, John, Taylor, Tumbler Ridge and Fort Nelson are present members
- Regional Directors can now join as well; the fee is \$10,000 each
