## DISTRICT OF CHETWYND BYLAW NO. 1070, 2018

Being a Bylaw of the District of Chetwynd for the Levying of Tax Rates for Municipal, Hospital and Regional District Purposes for the Year 2018.

The Council of the District of Chetwynd, in open meeting assembled, enacts as follows:

- 1. The following rates are hereby imposed and levied for the year 2018:
  - a) For all lawful general purposes of the Municipality on the assessed value of land and improvements taxable for general Municipal purposes, rates appearing in the row titled "GENERAL MUNICIPAL" of Schedule "A" attached hereto and forming a part of this bylaw.
  - b) For hospital purposes on the assessed value of land and improvements taxable for Regional Hospital District purposes, rates appearing in the row titled "PEACE RIVER REGIONAL DISTRICT HOSPITAL" of the Schedule.
  - c) For purposes of the Peace River Regional District on the assessed value of land and improvements only taxable for Regional Hospital District purposes, rates appearing in the row titled "PEACE RIVER REGIONAL DISTRICT - LAND AND IMPROVEMENTS" of the Schedule.
  - d) For purposes of the Peace River Regional District on the assessed value of improvements taxable for Regional Hospital District purposes, rates appearing in the row titled "PEACE RIVER REGIONAL DISTRICT IMPROVEMENTS" of the Schedule.
- 2. This Bylaw may be cited as "2018 Tax Rates Bylaw No. 1070, 2018".
