Ron Millsap addressed Council with the following concerns and questions:

- Why are we always having tax rate increases?
- Why did Canfor get a tax break of \$350,000.00?
- Take a look at spending habits and ask, "Is it necessary?" "How will it benefit?"
- Spent \$35,000.00 on a gazebo that could have been built for \$3,500.00
- Why aren't we paying down our debts first?
- The Economic Development Department needs to be eliminated, we don't feel we are getting anything from that department
- Is it true that the tax payers of Chetwynd pay the Peace River Regional District \$40,000.00 per year?
- Why hasn't the District of Chetwynd published a "Sunshine List" for 2018, 2017 or 2016?
- How many District employees have company credit cards?

Council thanked Ron Millsap for the presentation.

Council responded through the Chair that tax increases are required to fund the infrastructure underground that no one sees but is nevertheless vital to the community. The Chief Administrative Officer advised through the Chair that the District of Chetwynd publishes a Statement of Financial Information, referred to as a "sunshine list" by Mr. Millsap before June 30th each year as it is required to do so legislatively. The CAO further responded that several District employees do use corporate credit cards for work-related purchases.

"LNG Canada has advised Trans Canada to be ready to begin pipeline construction by the end of 2018. This does not mean that the project has the green light. It means be ready for the green light if it turns on.

Trans Canada anticipates commencing clearing of right of way by mid 2019 and line construction by 2020 pending a final investment decision by LNG Canada.

Worker camps are anticipated to be constructed near Chetwynd and in the Sukunka valley to accommodate approximately 1300 workers in total.

LNG Canada does not expect further delays. We wait for the final investment decision."
