Mark Alexander and Sabrine Locicero, BC Hydro provided Council with a brief presentation as outlined below:

Mark Alexander and Sabrine Locicero, BC Hydro re: Peace to Kelly Lake Capacitor Project (PKCP) 0510.20.01

• The Peace to Kelly Lake Capacitors Project consists of building capacitor stations between the Peace Region and the Kelly Lake Substation to help maintain the voltage levels of the 500 kilovolt transmission lines in the area, allowing more electricity to pass through

- The existing 500 kilovolt transmission lines in the area are already at 95% capacity
- This project also includes upgrades to equipment at the existing Kennedy Capacitor Station
- There are currently three alternatives being considered which consist
 of two to four new capacitor stations being built; hope to select an
 alternative by early 2019
- Project completion is expected to be complete between 2024 and 2026
