The consultant will also advise as requested on the implications of various documents published by Government and ENGOs as they relate to the socio-economic interests of the Peace River Regional District.

The Ministry of Transportation and infrastructure reported on its summer 2018 schedule of highway-improvement projects that include a number of bridges replacing culverts between Chetwynd and Tippy Corner just west of Willow Flats. These bridges will greatly enhance the ability of Highway 97 to withstand heavy rains. Significant sealcoating and paving projects will add to our driving comfort between Chetwynd and Tumbler Ridge and on the Jackfish Road."
