4. **Delegations & Presentations**

D-1 Chetwynd Chainsaw

Chris Larsen, Chetwynd International Chainsaw Carving Championship Society provided Council with an update as outlined below:

Carving

Society

- 2020 is the 4th year of Society; 16th year of Chainsaw Carving Championship event
- Increased appearance fees were given to carvers last year
- 2019 was the highest grossing quick carve
- Added \$10,000 to event last year

Delegation (continued)

- 2020 carver lineup consists of 4 Canadian, 4 US and 4 international carvers
- The Society is investing in capital this year, including two 10x10 retail tents; portable tool crib and tools
- 75% of the wood for this year's event has been put aside and almost ready to ship
- 8 of the 12 carvers have been sponsored

Council thanked Mr. Larsen for the presentation.

D-2 Jennifer Baddeley re: Electric Vehicles Jennifer Baddeley provided Council with an overview of Electric Vehicles as outlined below:

- Three types most commonly found in BC:
 - o Battery Electric Vehicle (BEV) Range 150-600 kms; electrical energy stored onboard which propels vehicle; regenerative braking
 - Plug-in Hybrid Electric Vehicle (PHEV) Electric Range 19-76kms, full range up to 1,035kms; electrical energy propels wheels for short period of time, then switches to Internal Combustion (IC) engine
 - Extended Range Electric Vehicle (EREV) Electric range 85-246kms, full range 203-676kms; electric energy propels vehicle; IC engine recharges battery
- Pros: low driving coast; low maintenance costs; environmentally friendly
- Cons: limited repair shops for electric vehicles (EVs); geographical challenges; "range anxiety"; affordability & availability; limited charging station infrastructure
- Level 1 & 2 Alternating Current (AC) Chargers: Level 1- about 4-20 hours charge time; Level 2 up to 5 hours charge time
- Level 1 & 2 Direct Current (DC)/Fast Chargers: Can charge up to 80% in 30-40 minutes
- Recommendations: Acquire BEV or EREVs for fleet; invest in more charging station infrastructure in town and surrounding area winterized; invite Emotive and the Community Energy Association to host info presentations in Chetwynd; have information incentives for personal EVs/Charging Stations at Municipal Office

Bylaws

6. Council Committee and Liaison Reports

CR-2 Councillor Reports Coun. Weisgerber reported that she attended the BC Natural Resources Forum in Prince George last week and advised the following:

On January 28 she attended a workshop on Crisis Communication:

- We need to make sure that our "Crisis Communications Plan" is up to date and the Mayor and Council are aware of it and understand it.
- We need to have staff look into getting training for Mayor and council on how to deal with media through a crisis, so wrong information is not given or promises are not made.

On January 29 she attended the Minister Breakfast for a presentation on Bill 41 – UNDRIP -United Nations Declaration on the Rights of Indigenous People. The keynote speaker was Premier Horgan, who talked about Bill 41 and the LNG pipeline which will be constructed. Premier Horgan spoke right after the LNG Rally, which was attended by 25-30 people.

On January 30 one Panel was "Fresh Perspectives from Tomorrow's Leaders" a group of young people who talked about Climate change and how they could help to fix things. They all are aware that they need the Oil and Gas for their laptops and phones. The keynote speaker was Chrystal Smith who is the Chief of the Haisla Nation. She talked about her life on the reserve and how she grew up there. She started out as an aide to Ellis Ros who was the Chief and is now the MLA of Skeena Regional District. She also talked about how their nation signed on with Coastal GasLink and how it is going to save their people from poverty by providing jobs and creating a proud nation.

Beside the session there was a lot of time to network. The Mayor and Coun. Weisgerber met with Trans Canada Energy about the Coastal GasLink project. They provided an update about the camp that was supposed to be going at 6km on Tumbler Ridge highway but which is now not going ahead because construction would displace the frogs, and also it's too wet. They did mention that they may partner with one of the First Nations to provide a space for the camp at a different location.

BC Hydro mentioned a project they are doing with EV Stations, the Economic Development Officer will contact them and find out more info.

BC Forest Council has more bursaries and scholarships available, so that information will be passed onto the Chetwynd Senior Secondary School.

Councillor Weisgerber Report (continued)

She sat by one of the owners from Chetwynd Mechanical Pulp at the banquet and asked if they are opening the mill up again; he advised that the company that was supposed to buy their product fell through after all the improvements they did and how there is a lack of wood they need. He had our picture taken, so Coun. Weisgerber is probably in China by now.

They also talked to Juergen Puetter about his RH2C renewable hydrogen east of Chetwynd project and hope that it materializes.

Surerus Place will be having their fund raiser this Saturday and the hope is that everyone goes.

Pine Valley Seniors are applying for a grant from Northern Development Initiative Trust to redo their kitchen, which Coun. Weisgerber is helping them with.

The Chamber of Commerce is working hard on the upcoming trade show and will be giving Council an update next month.

CR-3 Mayor's Report 0550.04 Mayor Courtoreille advised that he also attended the BC Natural Resources Forum last week and spoke to Premier Horgan regarding the caribou recovery plan and the Partnership Agreement; he advised that the Province cannot unilaterally change the Partnership Agreement, which requires the consent of all parties involved, including the Provincial and Federal governments and the West Moberly and Saulteau First Nations. Mayor Courtoreille told Premier Horgan that he has the ability to change the Partnership Agreement but has done nothing.

The District of Chetwynd will abstain from participating in any Partnership Agreement working groups unless the Premier approves the District of Chetwynd's representation on the Caribou Recovery Committee, as otherwise it may be perceived that we agree with the Partnership Agreement as written; the District of Chetwynd does not agree with the Partnership Agreement.

We had advice a year ago that we should step back and step out and maybe in hindsight that's what we should have done, but we are doing it now. It is very important that we stand together as a community, not just because we are here in Chetwynd but our community includes our surrounding areas West Moberly First Nations, Saulteau First Nations, Hasler, Jackfish, East Pine; we all live here. We wanted to make a point that we would like a voice in the Partnership Agreement but in the January 16, 2020 letter from Premier Horgan "we will not change any text in this agreement", we were told no you aren't going to be part of this Agreement.

Mayor's Report (continued)

Blair Lekstrom has resigned as the Premier's community liaison after it became very clear in the letter the Premier sent to the Peace River Regional District that he had no intention to change any text within the Partnership Agreement. We would like to thank Mr. Lekstrom for taking the initiative and for all of his hard work on this issue.

It is our hope that the Agreement does not affect what we do here.

WHEREAS ongoing labour shortages are prevalent in most small rural communities in Ambulance Halls throughout British Columbia, leading to increased response times and reducing patients' access to possibly lifesaving treatment;

AND WHEREAS B.C. Emergency Health Service (BCEHS)'s ambulance service is a vital component of life safety and access to healthcare for those who live and work in small rural communities, which are often a significant distance from fully-equipped hospitals:

NOW THEREFORE be it resolved that the North Central Local Government Association endorse the following resolution and forward it to the Union of British Columbia Municipalities for ratification and submission to the Province of British Columbia:

"THAT the Province of BC be requested to provide more resources along with a commitment to finding a long-term solution to staff shortages for small rural community ambulance services."

Background:

B.C. Emergency Health Service (BCEHS) has an ongoing, serious problem with recruiting and retaining ambulance personnel in small rural BC communities. This personnel shortage has resulted in periods of time with reduced or no ambulance service at all in small rural communities; this situation is more impactful in small rural communities because the distance to a fully-equipped hospital is often quite significant. It is important that all residents of BC have access to reliable local emergency services, and the BCEHS is a vital component of this service for rural residents.
