## 6. Council Committee and Liaison Reports

CR-2 Councillor Report Coun. Deck provided the following Peace River Regional District (PRRD) Solid Waste Committee Update:

- 2020 Fall Clean-up campaign saw a 59% overall increase in customers at the PRRD Landfills.
- Chetwynd Landfill had the highest increase, with 92% more customers.
- Reported increase of 17% more tonnage at the Chetwynd Landfill.
- Overall, the program of waiving the tipping fees during the Fall & Spring Clean-up campaigns was successful. Instances of illegal dumping has been reduced as customers have used the opportunity to dispose of their material in solid waste facilities for free.
- There is currently an opportunity to extend the life of the Chetwynd Landfill which could possibly double the length of time the landfill has left, to 16 years. The PRRD is currently going through the process with the Ministry of Environment.

CR-3 Mayor's Report Mayor Courtoreille provided the following verbal Mayor's report:

- In the beginning of December, a Provincial Order reduced the population of worksites such as Site "C" and Coastal GasLink due to COVID-19. Companies are required to draft a plan of next steps and work with Northern Health.
- PRRD Connectivity Discussed bringing fibre-optics into every house in the Peace River Regional District. It looks like it will possibly be 2022 before we will have fibre-optics running in our homes/businesses and in the rural areas.
