Ray Raatz, Forest Enhancement Society of BC, Chris Hayward, Duz Cho Logging & Don Rosen, Canfor Energy North provided Council with a project update on how First Nations and Industry are collaborating to take action on climate change.

The Forest Enhancement Society of BC provided a grant worth almost \$300,000 in funding to a partnership project called "Chetwynd Biology Recovery" led by Duz Cho Logging of the McLeod Lake Indian Band and Canfor Energy North.

The "Chetwynd Biology Recovery" is the utilization of residual waste fibre which is sold to the Canfor Energy North Pellet plant. This project helped avoid pile burning emissions and improved fibre utilization from existing cutting permits; this resulted in fewer greenhouse gas emissions. Council was provided with information on the economic benefits, environmental benefits and social benefits of the project.

Council thanked Mr. Raatz, Mr. Hayward and Mr. Rosen for the presentation.

WHEREAS cost is a significant barrier to people accessing contraception, particularly to people with low incomes, youth, and people from marginalized communities:

WHEREAS providing no-cost prescription contraception has been shown to improve health outcomes for parents and infants by reducing the risks associated with unintended pregnancy, and is likely to reduce direct medical costs on the provincial health system;

WHEREAS contraceptive methods targeted at men (such as condoms or vasectomies) are available at low cost or are covered by BC's Medical Services Plan, whereas contraceptive methods for people with uteruses (such as birth control pills, intra-uterine devices, or hormone injections) have high up-front costs, making access to contraception unequal and gendered;

THEREFORE BE IT RESOLVED THAT Council directs the Provincial Government be urged to make all prescription contraception in BC available at no cost under the Medical Services Plan."
