DISTRICT OF CHETWYND

BYLAW NO. 1142, 2021

Being a Bylaw to exempt certain properties from taxation for 2022

WHEREAS the *Community Charter* provides that Council may, by bylaw exempt from taxation any lands and improvements as therein specified;

AND WHEREAS Council deems it in the public interest to exempt certain properties from taxation;

NOW THEREFORE, the Council of the District of Chetwynd, in open meeting assembled, enacts as follows:

- 1. This Bylaw may be cited for all purposes as "District of Chetwynd Tax Exemption Bylaw No. 1142, 2021".
- 2. The following properties, being areas surrounding buildings set apart and in use for public worship, are exempt from taxation for 2022 under the provisions of Section 224(2)(f) of the Community Charter:
 - a.) **Exhibit 1 -** A portion of land, being 0.8015 ha (two acres), held by the *Church of the Nazarene*, Folio # 514-00252.000, described as Lot 18, Plan 10186, District Lot 1814, Peace River Land District, and *Civic Address*; 4908 47 Street.
 - b.) Exhibit 2 A portion of land, being 0.8015 ha (two acres), held by the <u>Chetwynd</u> <u>Congregation of Jehovah's Witnesses</u>, Folio # 514-01433.010, described as Lot 2, Plan 29072, District Lot 482, Peace River Land District, and Civic Address: 4380 North Access Road.
 - c.) **Exhibit 3 -** A portion of land, being 0.8015 ha (two acres), held by <u>Pentecostal</u> <u>Assemblies of Canada</u>, Folio # 514-00291.001, described as Lot 16, Plan 10202, District Lot 482, Peace River Land District, subject to R/W Plan 24099 and except Plan 25174, and *Civic address: 4212 53 Avenue NW*.

- 3. The following properties, which are owned by a charitable, philanthropic, society or other not for profit organization supported in whole or in part by public funds, are exempt from taxation for 2022, under the provisions of Section 224(2)(a) of the Community Charter to the extent indicated:
 - a.) **Exhibit 9** One hundred percent of the land and improvements owned by the *Tansi Friendship Centre Society*, Folio # 514-00173.000, described as Lot 4, Block 3, Plan 9154, District Lot 398, Peace River Land District, and *Civic Address:* 5301 South Access Road.
 - b.) **Exhibit 10 -** One hundred percent of the land and improvements owned by the *Tansi Friendship Centre Society*, Folio # 514-01490.650, described as Lot 1, Plan PGP37406, District Lot 398, Peace River Land District, and *Civic Address:* 5101 South Access Road.

- c.) **Exhibit 11** One hundred percent of the land and improvements owned by the *Tansi Friendship Centre Society*, Folio # 00195.000, described as Block A, Plan PGP9830, District Lot 398, Peace River Land District, and Civic Address: 4729 51 Street NW.
- d.) **Exhibit 12 -** One hundred percent of the land and improvements owned by the *Chetwynd Senior Citizen's Housing Society, Surerus Place,* Folio # 514-00572.000, described as Lot 1, Plan 17255, District Lot 398, Except Plan 20928, & 25396, Peace River Land District, and *Civic address: 5353 47 Avenue NW*.







Lot 16, Plan 10202, D.L. 482, P.R.D. (Pentecostal Assemblies of Canada)







A Portion of Block D, D.L. 482, P.R.D. (The Roman Catholic Episcopal Corporation of Prince Rupert)









Parcel B, Block A, Plan PGP9830, D.L. 398, P.R.D. (Tansi Friendship Centre Society)








