District Report

CR-2 Councillor Reports Councillor Nelson provided the following update:

BCNRF – The BC Natural Resources Forum was held in Prince George on January 17, 18 & 19th. The 3 day conference hosted speakers from parliament, local officials, and leaders in the Resource Sector. There were protestors outside of the Conference Centre when we arrived who had recently lost their jobs in Forestry who were there to make a statement to the Premier and to the attendees. There were families with young children holding signs and protesting the downturn in the forestry sector. Keynote speaker, Premier Eby did speak to the mill shutdown and stated that there would be government funds made available to these workers. Panels on the following topics were discussed: What's next for BC's forestry Sector, Innovative Archaeological Partnership between Indigenous Community and Industry, Progressive Indigenous Business Initiatives – of which Saulteau First Nation Chief – Justin Napoleon was a panelist. We further heard discussion on the future of the workforce, LNG Export, Mining & Indigenous Communities, Innovation in BC Natural Gas Production, & Hydrogen, now and in the future.

The Chetwynd Public Library – The Library Board held their AGM on January 24th. A new chair has been elected. Highlights include a letter from the Regional District dated January 23, 2023 stating that the New Library is a bit behind schedule due to the late arrival of the beams, but on budget financially. Director Dan Rose has confirmed that the PRRD has covered the financial shortfall while he waits to see if the District of Chetwynd is willing to contribute further. These are his words: "I have money to cover the shortfall and have committed to cover it. Past history tells us that large capital funding on shared projects has been shared equally usually. The District of Chetwynd is well short of that on this project. Any further assistance by the District of Chetwynd would be appreciated. I would like 450K. That still leaves the District well short of Area E contribution. If Chetwynd steps up, I can reduce my commitment. I had to commit while I wait for your decision."

NCLGA Conference Organizing Committee – The North Central Local Government Association Conference will be held on May 9, 10 & 11, 2023 in Dawson Creek and is being co-hosted by Chetwynd & Dawson Creek. Resolution deadline is March 10, 2023 @ 5:00pm. NDIT North Eastern RAC – I attended my first in-person meeting in Fort St. John on January 20, 2023. We discussed various projects seeking funding approval. We will meet again on March 17, 2023. I am willing and available to discuss funding opportunities with any of my colleagues or Community members who may have projects or know of community groups who require funding for projects that support Economic Development in the Northeast. www.northerndevelopment.bc.ca

BC Hydro GO Fund - Our group had our first meeting via zoom January 24, 2023. We approved 2 regional grants for community projects. There is a great funding opportunity here for non-profits to access funds of up to \$10,000. I would like to urge all community members to go online and view the criteria and applications at BC Hydro GO Fund. They are giving away \$100,000 a year and there are 3 more intakes in 2023.

- Corporate members of the Trust are Canfor, CN, Rio Tinto Alcan and West Fraser
- Chetwynd's original pledge amount was \$82,040. However as of March 31, 2022 this is now valued at \$136,494.30
