Dale Bumstead, South Peace Health Service Society provided Council with an update on the Bultery's Community House as outlined below:

- Grand Opening was on March 9, 2023
- Bultery's House is a 6-bedroom, 5-bathroom, wheelchair accessible home with a shared kitchen and eating area, two lounge areas, and shared laundry.
- Facility is located a block away from the Dawson Creek and District Hospital

- Provides short or long term affordable accommodation for individuals travelling to Dawson Creek for medical treatment and care.
- South Peace Health Services Society partnered with Lake View Credit Union on the Bultery's House Project
- Dawson Creek Society for Community Living in partnership with South Peace Health Services Society is the Operator of Bultery's House; an operating plan and agreement are in place.
- Support has been incoming and ongoing from throughout the Peace Region:
 - Peace River Regional District (PRRD) helped pay off the mortgage/loan.
 - Northern Development Initiative Trust (NDIT) provided a \$300,000 grant for renovations.
