District Report

CR-2 Councillor Deck provided the following update:

Councillor

Reports Chetwynd Communication Society:

- AGM was held on March 31, 2023
 - Bingo is the biggest financial contributor to the station. Continued diversification is needed so they don't have to rely solely on Bingo proceeds.
 - Originally, they were a training station but now they retain staff for a long time.
 - Two employees have passed: Don Pinkston and Chris Raczkowski
 - Have two new board members: Rochelle Galbraith and Mary Lynch

Chetwynd Volunteer Fire Department:

- As per meeting with the Chetwynd Volunteer Fire Department Association President:
 - The association has decided to disband.
 - Several long-term volunteers have retired.
 - Recruitment is ongoing.
 - The department needs volunteers.

UBCM Housing Summit:

- Although the majority of the conference brought up extremely good ideas, it seems that the majority of the issues would be in the hands of Senior governments.
 - Examples streamlining immigration for the credentialed trades people, plumbers, electricians etc. – more funding for low-income housing – interest rates – inflation – fast tracking permitting process.
- The points we could take away for Chetwynd and other rural or small towns would be:
 - We are very nimble and flexible with our permit processing.
 - Make sure our regulations make sense.
 - Robust communications on all projects.
 - Prioritize critical projects. Councillor Bassendowski pretty much summed this up in our last budget meeting. Pointing out that we need to prioritize our infrastructure needs.
 - The Provincial Government has permitted the building of multifamily units, 3 & 4 plexes on single lots.
 - We may wish to look at our minimum size home bylaw.
 - We should not hinder the ability for permits.
 - Staff should be innovative in their dealing so that we can get to yes.
 - Staff should be readily available.
 - Legislation is apparently on its way for short-term rentals.
 - The housing situation is very dynamic "there is no easy solution and there does not appear to be any political payback for solutions".

Councillor MacDonald provided the following Chetwynd International Chainsaw Carving Championship (CICCC) Society update:

- Carvers are confirmed and their information packages have been sent.
- Bios have been requested from the carvers.
- The Society is very nervous over the construction site of the new library. They mentioned meeting with staff from the District and the project lead with Celtic and there is some conflicting information. Celtic said that during that weekend, they plan to be digging for power and gas and prepping for paving where the vendors park meaning less space for the CICCC. This too will make parking a concern and access challenging.
- The Society is happy that the District will be moving fences allowing for an extra 20-30 feet of space, closer to the houses as well as additional lighting. The Society is gracious for the recent deposit from the District of the requested \$40,000.
- Wood will be delivered mid-May.
- 4 food vendors have confirmed.
- Security will be the Shriners/Masons.
- Advertisements for the event will start in May.
- The Society is still actively fundraising for the event, they have recently raised \$750 from the trade show, and did score keeping for a hockey tournament. There will be a 50/50 at the event and raffles. They were also recently successful in their Festivals Grant for \$11,500.
- There is the possibility of a soundstage for the event.
- All major pieces are in place for the event.
- Two meetings will be held in May.

Councillor Nelson provided the following update:

BC Hydro GO Fund:

• Approved 9 regional projects, one for the Chetwynd Arts Council for \$9,000 to purchase pottery making supplies, which they will use to offer free pottery classes to the community in coming months.

NDIT NE RAC:

• Various large grants approved in the region, some that positively impact Chetwynd, waiting for official announcement for those.

LGLA Conference in March:

 Attended with Mayor Courtoreille and Councillor Wark, a wonderful training and informational sessions for all local government representatives. Excellent opportunity for networking, and highly recommend to my colleagues that they attend next year if possible.

NCLGA Organizing Committee:

• Travelled to Dawson Creek with Ellen McAvany and Councillor Wark to work with our co-hosting community to plan what is sure to be an informational and exciting conference in May.

Library Board:

• Construction is well underway and the board is looking at purchasing furniture. Anticipating completion in Fall 2023.

Will be travelling with Mayor Courtoreille to the First Nations Major Projects Coalition Conference in Vancouver on Sunday and am looking forward to reporting on this.

Councillor Wark noted that the BC Hydro GO Fund provided a grant to the Meals on Wheels program.

CR-3 Mayor's Report 0550.04 Mayor Courtoreille provided the following Mayor's report:

"Mayor Courtoreille attended Council of Forest Industries on April 12, 13 & 14, 2023. The Minister of Forests, Bruce Ralston was in attendance.

I/ Mayor Courtoreille had an opportunity to speak with him, I made it clear to the Minister how devastating the closure of any Sawmill is in our community and the effects of such a closure on economy and the mental toll on the community. I talked with the Minister about our existing West Fraser mill and the possible fibre shortage occurring at this site. Minister Ralston is now looking into the shortage and his first thought was that the Canfor closure would help the West Fraser Sawmill to survive in Chetwynd. I asked him if the shortage was because of Permitting and one of the Assistance Deputies Ministers said they are getting close to some type of agreement. I don't know with who as he did not elaborate.

Also had a chance to speak with the CEO of West Fraser Timber Ray Ferris. Ray had concerns about the future of fibre in the Chetwynd area and other areas in BC.

I also met with Stephen Mackie, Canfor Executive Vice President of North America Operations. I conveyed my concern that Canfor Operation was not doing enough to help in securing fibre for our existing West Fraser Sawmill and he reassured me that Canfor and West Fraser were talking, and that Canfor was in a position to help. Without participating in these conferences, we do not get to have an audience with high profile Executives and with the appropriate Ministers i.e. Minister of Forests.

As for the conference it was very informative, and every session had components of Land use and Entitlement with our First Nations; from CN to all resource sectors like Mining, Oil & Gas, Forestry, Farming, Shipping Terminals, and Tourism, as all are being asked to collaborate and consult with First Nations. The time is here, and we must all look forward to the opportunity this brings to communities like ours. We are in a suitable location on a major Highway (97) and this brings opportunities that may arise from being on a major corridor. We should be preparing for the next level of opportunities."
