PURPOSE:

To enter into a partnership agreement for the 2023 Façade Improvement Program with ATS Chan Holdings Ltd, Chetwynd Dental Clinic address 5032 49th Avenue NW, (Lot 9, Block C, Plan PGP9830, District Lot 398 Peace River Land District) Chetwynd, BC VOC 1J0

SUMMARY/BACKGROUND:

Façade Improvement Program

The Façade Improvement program provides a grant to renovate, restore or redesign commercial façades and storefronts. The goal of the program is to encourage owners or tenants of commercial properties to invest in building façade upgrades that create a more interesting and appealing streetscape, attracting locals and visitors. Funding is provided by Northern Development Initiative Trust (NDIT) for this program in Chetwynd. 2023 Funding has been approved from NDIT and Chetwynd was awarded up to \$20,000 for 4 projects of \$5,000 rebate per application for the upcoming construction season.

A façade improvement application has been received for the program from Chetwynd Dental Care, ATS Chan Holdings Ltd (application is attached to the report 'Attachment A') for the existing structure in the Downtown Commercial (C1) zone at 5032 49th Avenue NW.
