Jonathan Brnjas, BC Emergency Health Services (BCEHS) provided Council with an update as outlined below:

Two Priorities:

Health Services re:

Update

- Provide timely and exceptional service to British Columbians when and where they need ambulance services.
- Be an outstanding employer in supporting the wellness of call takers, dispatch, and paramedic staff.

Changes to BCEHS:

- BCEHS is enhancing emergency services capacity in rural and remote stations that serve your community and surrounding areas.
- Conducting a national and international recruitment campaign, and also bringing recruitment and training to rural and remote communities.

Different Staffing Models:

- Full-time and regular part-time
- On pager at home or in community (Kilo shifts)
- Staffing model is dependent upon call volume and population.
- Ground response is supplemented by the participation of approximately 275 agencies in the first responder program.

Recent Improvements:

- New three-year collective agreement with the union that represents paramedics and dispatch staff includes changes which will help:
 - Stabilize staffing;
 - Increase employee retention;
 - Improve employee wellness; and
 - Improve coverage and patient care particularly in rural and remote areas.
- General wage increases in each year of the agreement.
- A cost-of-living allowance in 2023 & 2024.
- Permanent increased shift premiums.
- Transitioning the on-call scheduling model in rural and remote areas to a more tailored approach to the community and station.
- Improved benefits coverage for mental health and other health-care provisions.

On-Call Pay & Shift Premiums:

- On-call pay:
 - \$12/hr (up from \$2) + paramedic pay when responding to/receiving a call.
- Enhanced shift premiums for all nights and weekends.

Staffing in Chetwynd:

- Staffing starting to stabilize 75% full-time positions filled with the remainder anticipated to be filled in the next posting.
- Moved from 9 full-time employees (FTE) to 15 with the addition of a second full-time Bravo ambulance in late 2022.

CR-2 Councillor Reports CAO Steve McLain read a letter he received from Councillor Bassendowski dated August 7, 2023:

"Please accept this as notice that effective Nov 1, 2023, I will be relinquishing my position of Councillor for the District of Chetwynd. The careers of my family and I have moved us away from Chetwynd and as a result, I will no longer be able to fulfill my duties in this role. I will fulfill my duties remotely until Nov 1, 2023. This hopefully will give time for a by-election.

I feel I'm leaving this position with the district having a strong balance sheet in terms of Cash, Reserves and Borrowing Power. Chetwynd has done a good job upgrading their infrastructure but there is still a lot of old pipes in the ground and the cost of upgrades are always increasing. Roads continue to deteriorate, and the cost of paving continues to increase. A municipalities main source of income is taxes and the cost of providing services continues to rise and the notion of zero tax increases is not realistic or financially responsible. Chetwynd is financially strong in my opinion but is facing reduced tax revenue and uncertain grant securement as well as aging infrastructure. Asset Management and Intense Financial Planning is going to be key moving forward.

I would like to encourage many people in town to consider running for my seat on Council and carry on with strong objectives of providing our taxpayers with a safe, productive, and prosperous community to raise families in."

CR-3 Mayor's Report 0550.04 Mayor Courtoreille provided the following Mayor's report:

June 27, 2023:

- The Peace River Regional District (PRRD) was invited to attend a viewing of the Klinse-za Caribou Maternal Pen west of Chetwynd.
 - In the pen were two Caribou (a mother and calf).
 - Out of 22 Caribou 21 were pregnant.
 - The Guardian members are from West Moberly and Saulteau First Nations. The Guardians are on site 24 hours 7 days a week until the caribou are released (2 months). Here in the South Peace, it's quite important for the First Nation and the rest of the Region to have a species being brought back from extirpation.

July 4, 2023:

• Council met with Northern Health and were introduced to the new Health Services Administrator Rebecca (Becky) Borton. We look forward to working with Becky and Northern Health in the future.

July 5, 2023:

 The PRRD met with Minister Murray Rankin, Minister of Indigenous Relation & Reconciliation. The Board meeting held on June 8 was discussed; there was some controversy over a land sharing delegation put on by ZION Strategies LTD Dale Bumstead. Refer to PRRD website for the meeting recording.
