### BC Hydro Go-Fund:

- The Board approved grants to support four (4) non-profit groups in the area.
- One more year of funding has been secured from BC Hydro. This means that the BC Hydro Go-Fund committee has approximately \$108,000 more to support non-profit groups in our region next year.

### Chetwynd Public Library:

- Construction is moving along smoothly.
- Windows are being installed.
- Minister Kang has granted her approval for the tri-party agreement between the District of Chetwynd, the Peace River Regional District, and the Chetwynd Public Library Association.

Union of BC Municipalities (UBCM) Convention:

- Attended my first UBCM Convention in Vancouver, BC September 18 22, 2023 with Mayor Courtoreille and the Chief Administrative Officer, and Councillor's Deck and Smith.
- Attended sessions on the decriminalization of drugs, reconciliation, housing, wildfire, and healthcare.
- As a group of 2000 delegates, we passed resolutions on many important topics. Resolutions that emerged from the convention will be prioritized and brought to the province by the UBCM President.
- Met with Ministers from the Province to speak about issues that Chetwynd is experiencing.
- Met with Northern Health where we strongly urged the new Chief Executive Officer to pay attention to our struggles.
- The convention was hugely educational and an incredible networking opportunity.

Councillor Deck provided the following Chetwynd Communication Society update:

- The backup generator went out during the last power outage in Chetwynd. Will need to replace the generator.
- Bingo revenues are down.
- Staffing level at the radio station is down.

Councillor MacDonald provided the following Chetwynd International Chainsaw Carving Championship Society Update:

- Attended Annual General Meeting and Regular Meeting on September 26, 2023.
- The 2023 event was successful overall eight (8) Pro-Carvers were acting as assistants this year.
- This summer's fundraising was successful, raising over \$10,000. Three more fundraising events are planned for this year.
- Updating of tools is ongoing. They noticed that more carvers drove to Chetwynd this year, arriving early and bringing their own tools. Even with the carvers bringing their own tools, they were still short tools, and carvers needed to share.
- Event planning for 2024 and ideas for 2026 are being brought forward. The 2026 event will be the 20<sup>th</sup> competition and they are hoping to plan something extra special.
- New log distributor, so there will be larger logs.
- There have been lots of increased costs; increased insurance among other things. Fundraising mitigates these costs.

- The committee is considering increasing the prize amounts. There is a new competition in Alberta offering large prize amounts. Something to consider to continue intriguing the quality carvers.
- The committee now has the task of researching the nine (9) best carvers to invite for the next competition.
- The Chetwynd International Chainsaw Carving Champion Society is hoping to present to Council in November.
