

**DISTRICT OF CHETWYND
BYLAW NO. 1193, 2026**

Being a Bylaw of the District of Chetwynd for the Levying of Tax Rates for
Municipal, Hospital and Regional District Purposes for the Year 2026.


WHEREAS in accordance with Section 197 of the Community Charter, Council must, by bylaw, impose property value taxes for the year by establishing tax rates for

- a) The municipal revenue proposed to be raised for the year from property value taxes, as provided in the financial plan, and
- b) The amounts to be collected for the year by means of rates established by the municipality to meet its taxing obligations in relation to another local government or public body:

NOW THEREFORE Council of the District of Chetwynd, in open meeting assembled, enacts as follows:

- 1. The following rates are hereby imposed and levied for the year 2026:
 - a) For General Municipal purposes of the District of Chetwynd on the assessed value of land and improvements taxable for General Municipal purposes, rates appearing in the row titled "GENERAL MUNICIPAL" of Schedule "A" attached hereto and forming a part of this bylaw.
 - b) For hospital purposes on the assessed value of land and improvements taxable for Regional Hospital District purposes, rates appearing in the row titled "PEACE RIVER REGIONAL DISTRICT HOSPITAL" of Schedule "A".
 - c) For purposes of the Peace River Regional District on the assessed value of land and improvements only taxable for Hospital purposes, rates appearing in the row titled "PEACE RIVER REGIONAL DISTRICT - LAND AND IMPROVEMENTS" of Schedule "A".
 - d) For purposes of the Peace River Regional District on the assessed value of improvements taxable for Hospital purposes, rates appearing in the row titled "PEACE RIVER REGIONAL DISTRICT - IMPROVEMENTS" of Schedule "A".
- 2. This Bylaw may be cited as "District of Chetwynd 2026 Tax Rates Bylaw No. 1193, 2026".


